2.1	Youth Training Plan	Mandatory	Documented Youth Training Plan in place which broadly outlines the club mission, vision and goals regarding youth training. The plan also outlines the club's recruitment policy. The plan will include how the NL1 Club intends to facilitate the transition of players and coaches who have the ability to participate in the NL1.	
2.2	Liaison with State Technical Director	Mandatory	The Club Technical Director implements the agreed Youth Development Plan which has been endorsed by the State Technical Director. The Club Technical Director ensures that the coaching program is delivered, and maintains the appropriate records which will form the basis of the annual audit. NNSWF Technical Advisor will provide coaching support and two reports to Club NL1 Youth Coaches and Club Technical Director. The State TD will outline areas that need to be addressed by start of the 2020 season.	
2.3	Application of National Curriculum	Mandatory	Application of the National Curriculum	
2.4	Transparency of Fees	Mandatory	The Club must advise the Member Federation of the estimated costs, by type, incurred per season for each age group / team. The cost breakdown should also outline the component of fees which represents profit to the club. The fee structure must be reported to the Member Federation and FA for approval on an annual basis in accordance with Section 10.3. The Member Federation or FA may publicly advertise club fees centrally to facilitate easier comparison by consumers/parents/etc. In accordance with Section 10.3, the Member Federation or FA will have the ability to require the Club to re-set fees if they are determined to be unreasonable.

4.2	Business Plan	Mandatory	The club develops a detailed annual Business Plan and a broader long-term plan (3 years) which clearly outlines measurable KPIs and which is prepared by management and approved by the Board of the Club. Clubs will be required to provide NNSWF with an evaluation of their Business Plan on an annual basis.	
4.3	Member Forums	Mandatory	The Clubs hosts a Members Forum on two occasions per annum inviting parents, players, members, sponsors, etc. to present Club's Business Plan and to discuss ways to provide greater value to relevant stakeholders. Issues and feedback are documented and incorporated in the club's strategic planning process. The Members Forums are to be held in conjunction with the Clubs AGM and prior to the commencement of the NL1 season.	
4.4	Intermediaries (player agents)	Mandatory	The Directors of the Club must submit, on an annual basis, a Statutory Declaration confirming the existence and terms of any contractual, financial or other relationship with any intermediaries (including player agents).	
4.5	Private Academies	Mandatory	The Directors of the Club must submit on an annual basis a Statutory Declaration confirming there are no contractual, financial or other relationships with a Private Academy	
4.6	National Registration Regulations	Mandatory	The club must comply at all times with FA's National Registration Regulations

The frequency of the report shall accord with requirement 2.4 and be submitted to the Member Federation no later than 20 working days after the Grand Final (or final match) of the competition that season.	
10.2	Financial Reporting	Mandatory	The club shall submit its annual audited financial statements within 3 months of the end of the Club's financial year.	
10.3	Fee Report	Mandatory	In accordance with Criteria 2.4, the club shall submit a report on an annual basis outlining its proposed player fees for the year. The report shall contain a breakdown of the costs incurred in delivering the programs and will be assessed by the Member Federation and FA for their reasonableness. NNSWF will provide clubs with a Budget Justification Sheet to complete for the clubs youth grades. Both FA and the Member Federation shall have the power to require the club to validate information contained in the report or to require the club to revise its proposed fees. The report must be endorsed by the Member Federation and FA. The fee report must be submitted by 30 November each year in respect of the following year's season.
