Dear All,

The following memo outlines the relevant competition fees and player registration levies for Season 2024, which were approved by the NNSWF Board of Directors on Thursday 23rd November. The strong financial management of Northern NSW Football has enabled the Board of Directors to maintain the levels of the vast majority of our fees for Season 2024. The competition fee levy has been increased for Season 2024 to be in line with Men's NPL. However, this has been to help us elevate and equalise the prizemoney for Women's and Men's NPL. This will mean a total prize pool of \$20,000 split between Premier, 2nd place, Grand Final winners and runners-up as well as club championships and club of the year.
