## 1. SCOPE & DEFINITONS

- **1.1.** The National Premier Leagues Men's Northern NSW 2025 Competition Rules are to be read in conjunction with Northern NSW Football 2025 Premier Competition Regulations.
- **1.2.** All definitions as outlined in the Northern NSW Football 2025 Premier Competition Regulations will apply in this document.

### 2. FEES

- 2.1. Participation Fee
  - (a) The total Participation Fee is approximately \$18,487.29.
  - **(b)** This Fee includes the following:

(c) The Participation Fee will be paid over four instalments:

# 3. COMPETITION STRUCTURE

- **3.1.** Each Club will be required to field and maintain the following Teams in NPL Men's NNSW Competition:
  - (a) Senior Competition:
    - (i) First Grade.
    - (ii) Reserve Grade;
- **3.2.** The Senior Competition is comprised of 12 Clubs and played on a home and away basis over 22 rounds.
- **3.3.** Points will be awarded in accordance with the 2025 Premier Competition Regulations.

# 4. FINAL SERIES

- **4.1.** The senior Finals Series will be conducted under the following format:
  - (a) Finals Series Fixtures:

- **(b)** Weeks 1-3 finals host Venue is determined solely on the basis of first named  $1^{st}$  Grade Teams as outlined in Rule 4.1 (a).
- **(c)** Reserve Grade Finals Series Matches will take place at the same Venue as their equivalent 1<sup>st</sup> Grade Competition Fixtures.
- **(d)** The highest placed Team on the Official Points Table (1st Grade) reserves the right to nominate their preferred playing day.
- **(e)** NNSWF reserves the right to schedule NPL Finals Series at their sole discretion, taking into account all other Matches in Premier Competitions.
- **(f)** If winners for the 1<sup>st</sup> Grade Finals Series Matches outlined in Rule 4.1 (a), Weeks 1-3 cannot be determined at the conclusion of normal time, then the following will occur immediately after the conclusion of the match:
  - (i) Extra time of 2 equal periods of 15 minutes will be played in accordance with FIFA Law 8:
  - (ii) If at the conclusion of both periods of extra time, a winner has not been determined, penalty kicks will be taken in accordance with FIFA Laws of the Game to determine a winner.
- **(g)** If winners for the Reserve Grade Finals Series Matches outlined in Rule 4.1(a), Weeks 1-3 cannot be determined at the conclusion of normal time, then the following will occur immediately after the conclusion of the match:
  - (i) Penalty kicks will be taken in accordance with FIFA Laws of the Game to determine a winner:
  - (ii) For the avoidance of doubt, no extra time will be played in Reserve Grade Competition Fixtures for these Matches.
- **(h)** For all Senior Grand Final matches outlined in 4.1 (a) Week 4, if a winner cannot be determined at the conclusion of normal time, then the following will occur immediately after the conclusion of the match:



- (i) For 1st Grade, extra time periods will be 2 equal periods of 15 minutes.
- (ii) For Reserve Grade, extra time periods will be 2 equal periods of 10 minutes.
- (iii) If at the conclusion of both periods of extra time, a winner has not been determined, penalty kicks will be taken in accordance with FIFA Laws of the Game to determine a winner.
- (i) NNSWF will determine the Venue, kick-off time and playing date of all NPL Grand Finals at its sole discretion.
- (j) NNSWF reserves the right to allocate changerooms for all NPL Finals Series matches at its sole discretion.

## 4.2. Senior Finals Eligibility

- (a) The highest grade in which a Player is named as a starting Player, will be considered to be the grade in which that Player has participated in for that round.
- **(b)** The grade a Player has played the highest number of their Matches as shown in Squadi is the lowest grade in which they are eligible to participate in the Final's Series.
  - (i) A Player is eligible to participate in the lowest grade they qualify for in accordance with 4.2 (b) and grades above.
  - (ii) Should a player have played an equal number of their Matches in all grades they participated in, they will be considered eligible to participate in those grades.
- **(c)** Subject to any suspension and/or age eligibility a Player is eligible to participate in the grade they have qualified for and grades above.
- **(d)** Club may seek special dispensation for the specialist position of Goalkeeper. All requests will be considered on an individual basis by NNSWF.
- **(e)** Should a Team be removed or withdrawn from a competition, NNSWF reserves the right to adjust finals eligibility requirements for remaining Clubs on the basis of a Player being eligible for the Team they have played the majority of matches for and the corresponding grades above.
- (f) These eligibility criteria apply to all Promotion-Relegation Playoffs.

### 5. PROMOTION AND RELEGATION

- **5.1.** At the conclusion of the Regular Season,
  - (a) the team finishing in 12<sup>th</sup> position of NPL Mens Northern NSW, will be automatically relegated to Northern League One.
  - **(b)** The team finishing in 11<sup>th</sup> position must take part in the Promotion-Relegation Playoff series as outlined in section 5.2
  - **(c)** The team finishing 1<sup>st</sup> in Northern League One will be automatically promoted to NPL Mens Northern NSW.
- **5.2.** Promotion-Relegation Playoff (1st Grade Only)



- (a) At the conclusion of the Regular Season, the following four teams will compete in the Promotion-Relegation Playoff to determine the 12<sup>th</sup> and final team for NPL Mens Northern NSW for season 2025:
  - (i) 11th placed team in NPL Mens Northern NSW
  - (ii) 2<sup>nd</sup> placed team in Northern League One
  - (iii) 3<sup>rd</sup> placed team in Northern League One
  - (iv) 4th placed team in Northern League One
- **(b)** The playoff semi-finals will be played as follows over two legs:
  - (i) Playoff Semi-Final 1 first leg: 4<sup>th</sup> Placed team in Northern League One v 11<sup>th</sup> Placed team in NPL Mens Northern NSW
  - (ii) Playoff Semi-Final 2 first leg: 3<sup>rd</sup> Placed team in Northern League One v 2<sup>nd</sup> placed team in Northern League One
  - (iii) Playoff Semi-Final 1 second leg: 11<sup>th</sup> Placed team in NPL Mens Northern NSW v 4<sup>th</sup> Placed team in Northern League One.
  - (iv) Playoff Semi-Final 2 first leg: 2<sup>nd</sup> placed team in Northern League One v 3<sup>rd</sup> Placed team in Northern League One
  - (v) The team with the highest aggregate score at the conclusion of both semi-finals will advance to the Promotion-Relegation Playoff Final.
  - (vi) If the aggregate scores are level at the conclusion of Normal Time of the Semi-Final second leg, then the following will occur immediately after the conclusion of the match:
    - 1. Extra time of 2 equal periods of 15 minutes will be played in accordance with FIFA Law 8;
    - 2. If at the conclusion of both periods of extra time, a winner has not been determined, penalty kicks will be taken in accordance with FIFA Laws of the Game to determine a winner.
  - (vii) For the avoidance of doubt, the away goals rule will not apply in the Promotion-Relegation Playoff
- (c) The Promotion-Relegation Playoff final will be played as a standalone match as follows:
  - (i) Winner of Semi-Final 1 v Winner of Semi-Final 2
  - (ii) If the scores are level at the conclusion of normal time, then the following will occur immediately after the conclusion of the match:
  - (iii) Extra time of 2 equal periods of 15 minutes will be played in accordance with FIFA Law 8;
  - (iv) If at the conclusion of both periods of extra time, a winner has not been determined, penalty kicks will be taken in accordance with FIFA Laws of the Game to determine a winner.
  - (v) The match will be played at a venue determined by Northern NSW Football
- **5.3.** Should the team finishing in 1<sup>st</sup> place of Northern League One, be unable to be promoted the following alteration to the promotion and relegation system:



- (a) The team finishing 11<sup>th</sup> place in NPL Northern NSW will retain their position in the division for season 2025.
- **(b)** The team finish in 12<sup>th</sup> place in NPL Northern NSW will enter the Promotion-Relegation Playoffs which will be played as follows:
  - (i) Playoff Semi-Final 1 first leg: 4<sup>th</sup> Placed team in Northern League One v 12<sup>th</sup> Placed team in NPL Mens Northern NSW
  - (ii) Playoff Semi-Final 2 first leg: 3<sup>rd</sup> Placed team in Northern League One v 2<sup>nd</sup> placed team in Northern League One
  - (iii) Playoff Semi-Final 1 second leg: 12<sup>th</sup> Placed team in NPL Mens Northern NSW v 4<sup>th</sup> Placed team in Northern League One.
  - (iv) Playoff Semi-Final 2 first leg: 2<sup>nd</sup> placed team in Northern League One v 3<sup>rd</sup> Placed team in Northern League One
- (c) All other Promotion-Relgation Playoff regulations outlined in section 5.2 will remain.
- **5.4.** Should any teams from Northern League One that qualify for playoffs be unable to be promoted, then the remaining qualified teams will move up one position in the playoff hierarchy. For example, if the team finishing in 2<sup>nd</sup> place in Northern League One is unable to be promoted then the team finishing in 3<sup>rd</sup> placed will be deemed to have finished in 2<sup>nd</sup> place for playoff purposes.
  - (a) No further teams will be added to the playoffs in the situation outlined in 5.4, and the 11<sup>th</sup> placed team in NPL Northern NSW will advance directly to the Playoff Final.
- **5.5.** If two teams from Northern League One that qualify for playoffs be unable to be promoted, the remaining two teams will advance directly to the Playoff Final.
- **5.6.** If all three teams from Northern League that qualify for playoffs be unable to be promoted, the 11<sup>th</sup> placed team in NPL Northern NSW will retain their position in the division for season 2026.
- **5.7.** If all teams finishing in the top 4 position of Northern League One are unable to be promoted, the teams finishing in 11<sup>th</sup> and 12<sup>th</sup> place of NPL Northern NSW will retain their positions for season 2026.
- **5.8.** For the avoidance of doubt Northern NSW Football, will at its sole discretion, determine whether teams in Northern League One meet the required minimum standards for promotion into NPL Northern NSW.

#### 6. ADMISSION CHARGES

- 6.1. Scheduled Fixture
  - **(a)** The following fees are the maximum admission fees which can be charged for senior Matches:

**(b)** Clubs are not required to charge admission fees, it is at the club's discretion.



- (c) Admission fees may only be charged for senior football:
  - (i) In the event of youth Matches (including 18 Years) occurring on the same day at the same Venue as senior Matches, admission fees may only apply from half time in the youth Match immediately preceding the first senior match.

### 6.2. Rescheduled Fixture

(a) Where a 1<sup>st</sup> Grade Team participates in a rescheduled fixture:

### 7. CLUB PASSES

**7.1.** Each Club will be provided the following passes:

| (a) | VIP       | 10 |

- **7.2.** Clubs are responsible for ensuring that all Club Associates adhere to the required terms and conditions noted on their specific pass.
- **7.3.** Grand Final ticket prices will be determined by Northern NSW Football.

## 8. AGE RESTRICTIONS

- **8.1.** For all instances, with the exception of 8.2 (a) a Player's age is determined by the age they turn during that calendar year.
- 8.2. 2025 Senior Grades
  - (a) Minimum age to play in Senior Grades is 15 years old.
  - **(b)** All Clubs, are required to register and maintain a minimum of 7 Players born 2005 or later in their Reserve Grade Roster.
- **8.3.** A Player registered in the Player Points System Roster (1<sup>st</sup> Grade) is not permitted to participate in a Youth Grade competition.

## 9. PLAYER REGISTRATIONS

**9.1.** The minimum number of Players permitted to be registered per Club is:

### 9.2. Player Eligibility Exemptions

- **(a)** Players are not permitted to play down into an age group or grade lower than they are age eligible for with the exception of:
  - (i) In the event of an injury or unavailability to a Goalkeeper and the subsequent goalkeeper from the age group or grade below is unable to participate, Clubs must complete and submit the following form <a href="Eligibility Form">Eligibility Form</a> allowing for permission to play the Goalkeeper from the corresponding next age group or grade above.
  - (ii) The <u>Eligibility Form</u> must be completed and submitted by a Club Executive or the Club Technical Director by or before 9am the next Business Day following the completion of the Match.
  - (iii) Clubs are responsible for collecting and storing applicable evidence to support the usage of a Goalkeeper from the higher age group which may be requested by NNSWF
  - (iv) In the event a Player or Goalkeeper does not meet the above criteria, Clubs may apply in writing to NNSWF to request special exemption.
  - (v) Should a Club be found guilty of the using a Goalkeeper from a higher grade to gain Sporting Advantage, which may include taking adequate steps in assembling their squads appropriately, they may be subject to NNSWF Premier Competition Regulation 7.6 and corresponding sanctions.

### **10. PLAYER POINTS SYSTEM**

- 10.1. Each Club is subject to the requirements of the Player Points System as set out by Football Australia.
  - (a) For season 2025 each Club is allocated 180 PPS points for their 1st Grade squad.
    - (i) Promoted Clubs are allocated an additional 20 points for their first season as prescribed by Football Australia.
  - **(b)** Each Club must maintain a minimum PPS Roster of 20 Players and a maximum PPS Roster of 23 Players at all times throughout the NPL season.
  - **(c)** Should any Club's PPS Roster fall below the minimum 20 Players, for any reason, the Club will be required to nominate the appropriate number of Players from their Reserve Grade to fulfil the requirements outlined in Rule 10.1 (b). Overage Players will not be considered in this instance.
- 10.2. Clubs will be required to submit PPS documents to NNSWF as below:

**10.3.** Clubs will be permitted to make unlimited changes to their original PPS squad during the following window:

## 10.4. Reserve Grade

(a) Players born 2004 or earlier on the Reserve Grade Roster, will not be permitted to play 1<sup>st</sup> Grade Matches unless they have been added to the PPS in line with Rule 10.3.



- **(b)** Clubs are permitted to transfer overage Players into the PPS Roster in the window outlined in Rule 10.3.
- **10.5.** Should a Player listed within a PPS squad be deregistered outside of the allocated PPS windows, the Club will not be able to draft a replacement Player into its PPS squad until the PPS window opens, with the exception of Rule 9.1 (c).
- **10.6.** Changes to a PPS squad will not be permitted in the event of a Player(s) suspension.
- **10.7.** Any Club found to deliberately mislead or breach the PPS by knowingly providing incorrect information on a Player/s history will be subject to disciplinary action as determined by NNSWF.

### 11. MATCH DURATION

11.1. Each Competition Fixture shall consist of the following:

**11.2.** Additional time for injuries and stoppages in 1<sup>st</sup> Grade may be added at the discretion of the referee.

### 12. MATCH BALLS

- **12.1.** Approved match balls must be used in all NPL Competition Fixtures.
- 12.2. Mitre is the approved match ball for season 2025.
- 12.3. The following match balls must be used:

## 13. TEAM OFFICIALS & TECHNICAL AREA

**13.1.** Clubs will be permitted to the following number of Team Officials, substitute and / or interchange Players within in the Technical Area during a fixture:

- (a) All Team Officials & Players must be eligible to participate in the Match and named accordingly on the Official Team Sheet on Squadi.
- 13.2. All registered Team Officials must display their NNSWF Accreditation Pass at all times.



**13.3.** A Player or Team Official who has been expelled or is serving a suspension is not permitted to be in the Technical Area during a fixture in accordance with Regulation 37 of 2025 Premier Competition Regulations.

### 14. SUBSTITUTION OF PLAYERS

#### **14.1.** 1<sup>st</sup> Grade

- (a) Each competing Team may name a maximum of 7 substitute Players on the Official Team Sheet and at its discretion use 5 substitutes during a Match, 1 of whom may be the Goalkeeper;
- **(b)** To reduce disruption to the Match, each Team will have a maximum of 3 opportunities to make substitutions during the game; substitutions may also be made at half-time which does not count towards the maximum of 3 opportunities. If both teams make a substitution at the same time, this will count as 1 of the 3 opportunities for each team.
  - (i) For Matches where Extra Time is required (Rule 4.1) each Team will have 1 additional opportunity to make a substitution.

#### 14.2. Reserve Grade

- (a) Each competing Team may name a maximum of 5 substitute Players on the Official Team Sheet and at its discretion use 5 substitutes during a Match, 1 of whom may be the Goalkeeper;
- **(b)** To reduce disruption to the Match, each Team will have a maximum of 3 opportunities to make substitutions during the game; substitutions may also be made at half-time which does not count towards the maximum of 3 opportunities. If both teams make a substitution at the same time, this will count as 1 of the 3 opportunities for each team.
  - (i) For Matches where Extra Time is required (Rule 4.1) each Team will have 1 additional opportunity to make a substitution.

## **15. RESCHEDULED FIXTURES**

# **15.1.** Senior Competitions

- (a) Senior Competition Fixtures postponed due to inclement weather, or any other causes will in the first instance be rescheduled to the next available catch-up round should that catch-up round fall within 30 days of the postponed fixture, with preference given to matchdays where multiple grades have been postponed.
- **(b)** Should there be no available catch-up rounds within the parameters set out in 15.1(a), the matches will be replayed the second week after the postponement as follows, with due consideration given to previously scheduled Competition Fixtures

- **(c)** Should a match not be able to be rescheduled in line with 15.1 (a) or (b) then NNSWF will determine the best available date within reasonable timeframes.
- (d) The use of schedule catch-up rounds will be at the discretion of NNSWF.



- **(e)** NNSWF reserves the right at its absolute discretion to consider all available options to ensure that as many fixtures as possible are played during a period of inclement weather or postponements, and where any fixture may have a bearing on a final's series position all endeavours will be made to reschedule fixture.
- **15.2.** Should inclement weather persist and cause the postponement of rescheduled fixtures, NNSWF will liaise with the Home Club to determine new Competition Fixture dates.
- **15.3.** The availability of Players or Team Officials will not be taken into consideration when determining rescheduled fixtures.

#### **16. PRIZE MONEY**

**16.1.** Prize money shall be awarded in accordance with the following table:

| Club of the Year                      | \$ 1,000.00 |

#### 17. MEDIA & MARKETING

- **17.1.** Clubs will be required to actively operate Social Media accounts that are up to date, relevant and provide information to their members in accordance with NNSWF's Social Media Policy.
- **17.2.** Clubs may be required to erect 3 NPL sponsorship banners on the inside of the playing field perimeter fencing with 1 banner erected behind each set of goalposts and the remaining banner on or as near as possible to the halfway line on the opposite side of the ground to the grandstand.
  - (a) Clubs who fail to adhere to this will be subject to a fine in accordance with Appendix A of the 2024 Premier Competitions Regulations.

## 18. NATIONAL SECOND DIVISION

- **18.1.** The club finishing in 1<sup>st</sup> in NPL Men's First Grade will be invited to participate in Football Australia's National Second Division competition at the conclusion of the 2025 season.
  - (a) Should the club finishing in 1<sup>st</sup> position on the ladder be unable to accept this offer, then the team in 2<sup>nd</sup> position will be invited, and this will continue until the position has been taken up.

## **AWARD ELIGIBILITY CRITERIA**

- (1) A Player or Team Official is ineligible to win the following awards if the Player / Team Official is:
  - (A) suspended as a result of receiving a Direct Red Card in Match;
  - (B) suspended as a result of a determination of a body under the Disciplinary Regulations;
  - (C) convicted of an anti-doping offence;
  - (D) found guilty of serious misconduct as determined by FA; and / or
  - (E) found guilty of breaching an FA Statute and NNSWF determines that as a result of such breach the Player is ineligible to win any of the aforementioned awards.
- (2) Player / Team Official ineligibility only applies to the following categories:
  - (A) Player of the Year;
  - (B) Young Player of the Year;
  - (C) Coach of the Year.
