Dear All,

The following memo outlines the relevant competition fees and player registration levies for Season 2026, which were approved by the NNSWF Board of Directors on Thursday 27th November. The continued strong financial management of Northern NSW Football has enabled the Board of Directors to maintain the levels of the vast majority of our fees for Season 2026. There has been a slight increase in the Football Australia Levy.

All payments relating to player registrations will again be made through the online Play Football system. Whilst we will still outline the player registration costs in this memo, in the interests of transparency, they will not form a part of the total fee invoices in 2026.

In line with Season 2025, NPLM players for Season 2026 will only need to have paid the FA Levy in order to be registered and approved in Play Football to be eligible to play. Clubs will be invoiced for the remaining balance of the NNSWF components in July 2026 after the 30th June registration cut-off date.
