

## **Newcastle Permanent Virtual Skill Challenge**

### **Terms & Conditions**

- 1 - The promoter is: Northern NSW Football Ltd (“NNSWF”) ABN 80 001 887 467 whose registered office is at 13 Park Road Speers Point NSW 2284.
- 2 – The competition is sponsored by Newcastle Permanent Building Society Limited (Newcastle Permanent) ACN 087 651 992 Australian Credit Licence / AFSL 238273, 307 King Street Newcastle West NSW 2302.
- 3 - The competition is open to residents within NSW, who have a public Facebook/Instagram account, except employees of Northern NSW Football and Newcastle Permanent, or anyone otherwise connected with the organisation or judging of the competition.
- 4 - There is no entry fee and no purchase is necessary to enter this competition.
- 5 - By entering the competition an entrant is indicating his/her agreement to be bound by these terms and conditions.
- 6 - The competition will be run through Facebook and Instagram.
- 7 - Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.
- 8 - Closing date for entry will be 11.59pm Sunday 5 December 2021. After this date no further entries will be permitted.
- 9 - No responsibility will be accepted by NNSWF for entries not received for whatever reason.
- 10 - The rules of the competition and how to enter are as follows:
  - Film yourself doing your best football skills and tricks.
  - Upload your video to your public Facebook or Instagram account, using the hashtag #VirtualSkillChallenge and tagging Northern NSW Football (nnswf).
  - Entrants must follow/like Northern NSW Football and Newcastle Permanent on the social media channel they use to enter the competition.
- 11 - Prizes are as follows:
  - First Prize - \$250 account credit into a Newcastle Permanent account in the winner’s name + one Newcastle Permanent branded beach umbrella. Total value \$300.
  - Second Prize - \$150 account credit into a Newcastle Permanent account in the winner’s name + one Newcastle Permanent branded beach umbrella. Total value \$200.

- Third Prize - \$50 account credit into a Newcastle Permanent account in the winner's name + one Newcastle Permanent branded beach umbrella. Total value \$100.

Total RRP value of total prize pool = \$600 AUD

Limit of one (1) prize per entrant. No bonus prizes will be awarded.

12 - Prizes are as stated and no cash or other alternatives will be offered. Prizes are not transferable. Prizes are subject to availability and the promoter reserves the right to substitute any prize with another of equivalent value without notice. The promoter is not responsible for inaccurate prize details supplied to any entrant by any third party connected to the competition.

13 - Northern NSW Football will choose five finalists from entries across northern NSW via a panel of judges appointed by the promoter. Finalists will be chosen on the criteria of originality, football creativity, difficulty and presentation of NNSWF values (*United, Transparent, Collaborative, Respectful, Best Practice, Accountable*). The northern NSW football community will then have the chance to vote for their favourite video via reactions on the "Finalists" social media posts on Facebook and Instagram from Tuesday 7 December 2021. Voting will be open until 5pm Tuesday 14 December 2021. The video with the most reactions/likes tallied across Facebook/Instagram will win first prize, the second most second prize and third most third prize.

14 - The winner will be notified via Direct Message on the social media account they used to submit their entry within 28 days of the competition closing. If any winner cannot be contacted or do not claim the prize within 14 days of notification, the promoter reserves the right to withdraw the prize from the winner and select a replacement winner with places directly below promoted to replace places above. In the event there is no prize winner or a prize winner cannot be found, this result will be published on the promoter's website.

15 - The promoter will notify the winners when and where the prize can be collected. Each winner must have an open Newcastle Permanent account to receive the account credit. The account credit will be paid into the winner's Newcastle Permanent account within seven business days of claiming their prize.

16 - Although there are no anticipated direct costs relating to receiving a prize, any taxes (excluding GST) which may be payable as a consequence of receiving a prize are the sole responsibility of the winner.

17 - Terms and Conditions for Newcastle Permanent accounts and identification procedures are applicable to the winner and their parent / legal guardian (where relevant).
